- In the website www.enterisi.it (download area) it is published the 2011 list of the notifications transmitted through the network RASFF, concerning rice and rice products. Herewith attached there are some graphs summarizing the same data. In comparison with the previous year, the total number of notifications lowered (54 instead of 75) and the alert notifications percentage decreased from 35 to 28%. It is worth notice that 11 out of 15 alert notifications concerned GM rice or rice preparations imported from China.

# **GMO & BIOTECH**

- According to the annual biotech crop report released by ISAAA (International Service for the Acquisition of Agri-biotech Applications), global adoption of biotech crop technology continues at unprecedented rates. During 2011, an additional 12 million hectares were planted representing an annual growth rate of 8 percent over 2010. 160 million hectares were planted by 16.7 million farmers in 29 countries, including 19 developing countries and 10 industrial countries. Such adoption represents a 94-fold increase in hectares planted since 1996, when GM crop commercialization started, making biotech crops the fastest adopted crop technology in recent history.

### **ORGANIC FOOD**

- The publication 'The World of Organic Agriculture 2012' has recently been launched: statistics reveal growth in markets and stability in the areas of production. The market for organic products continues to grow, considerably in the USA and many European countries. 37 million hectares of agricultural area was certified organically in 2010. Australia and Argentina continue to have the highest percentage of organically managed land (12 million and 4.2 million hectares, respectively). The annual per capita consumption is highest in small Central and Northern European countries (Switzerland, 153 €; Denmark, 142 €; Luxembourg, 127 €; Austria, 118 €).

## LAWS, STANDARDS & AGREEMENTS

- **Commission Regulation (EU) No 1129/2011** concerning a coordinated multiannual control programme of the Union for 2012, 2013 and 2014 to ensure compliance with maximum residue levels of pesticides and to assess the consumer exposure to pesticide residues in and on food of plant and animal origin. Sampling and analysis for rice have to be held in 2014.
- **Commission Regulation (EU) No 1267/2011** laying down detailed rules for implementation of Council Regulation (EC) No 834/2007 as regards the arrangements for imports of organic products from third countries.
