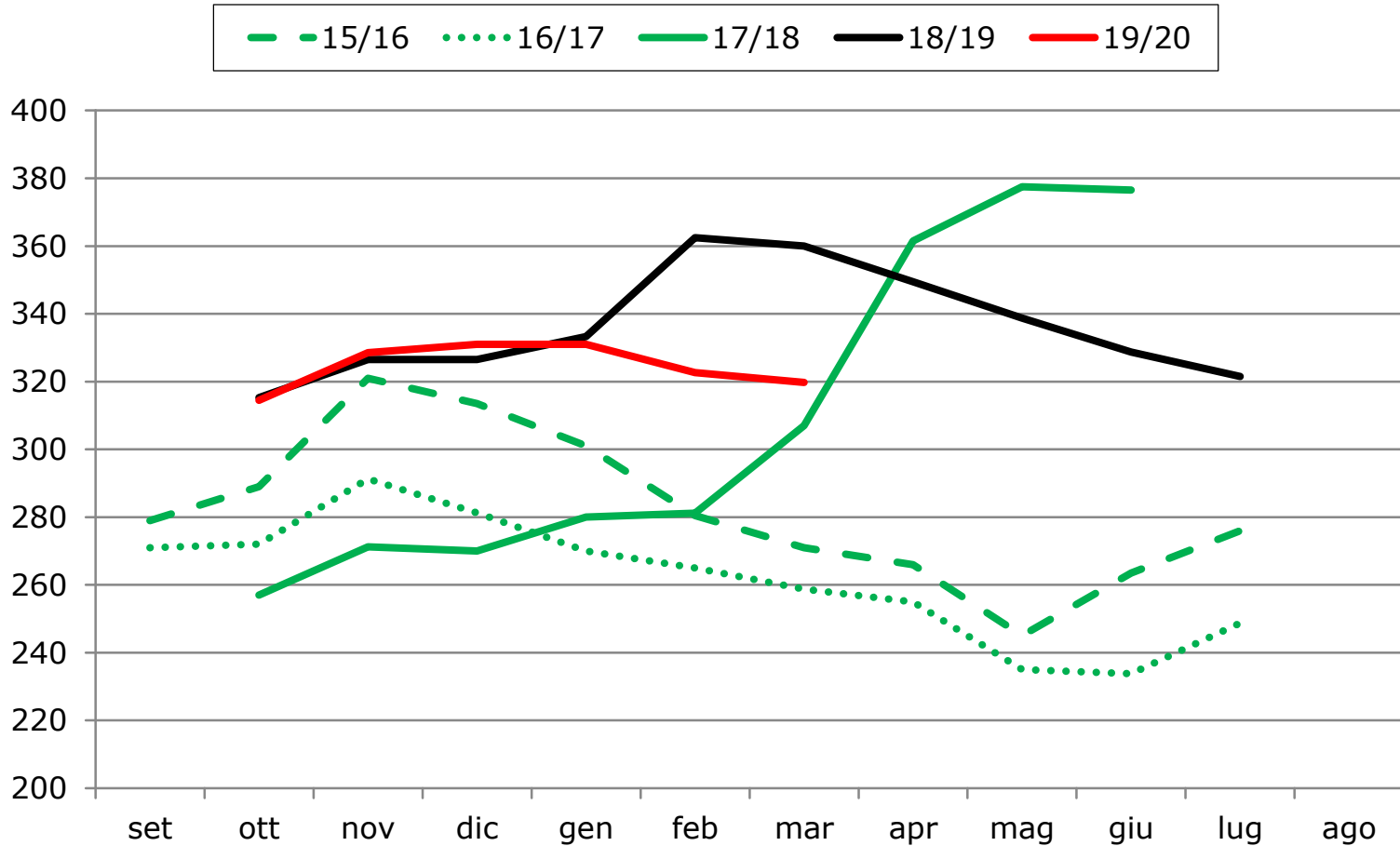

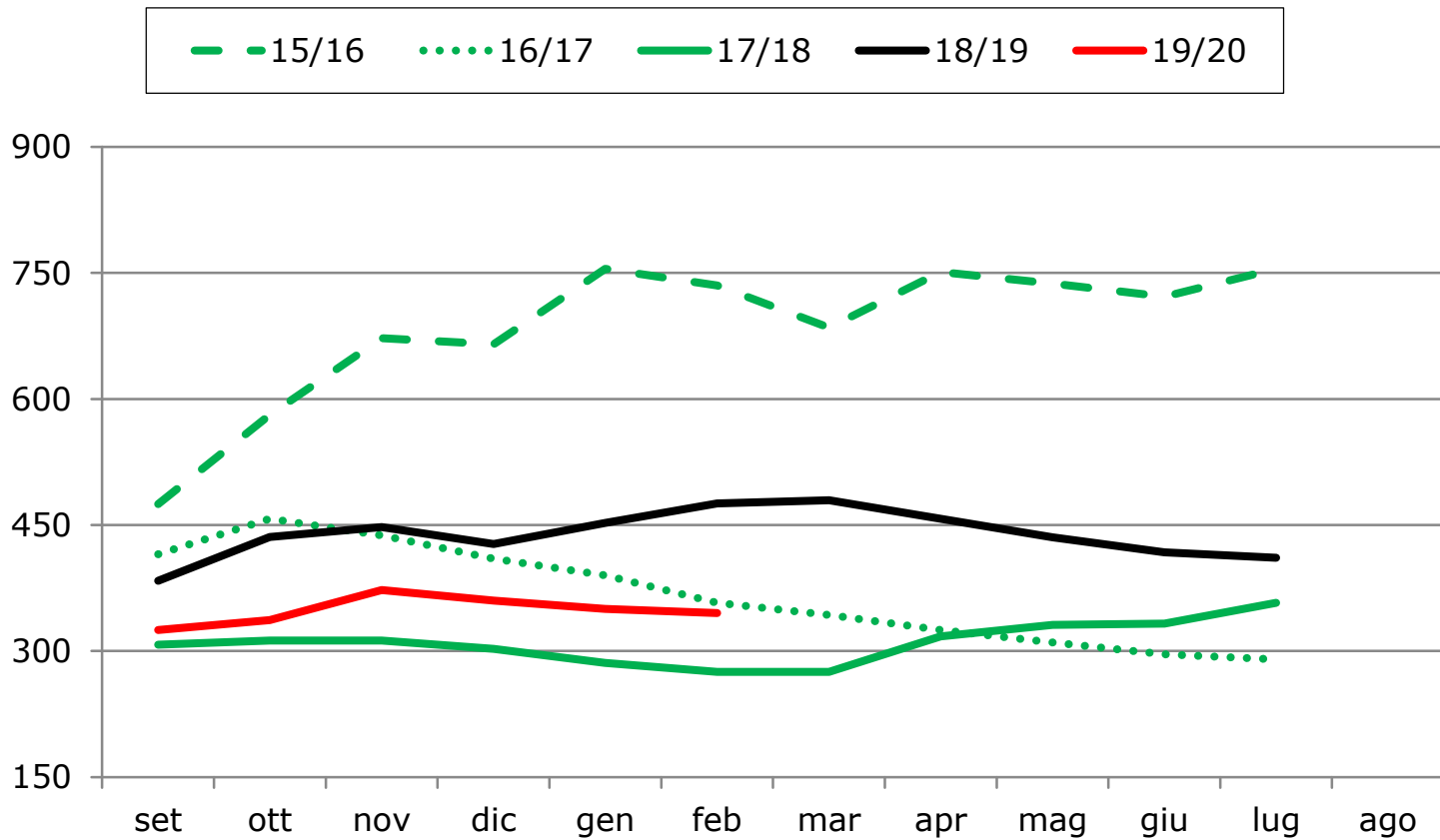

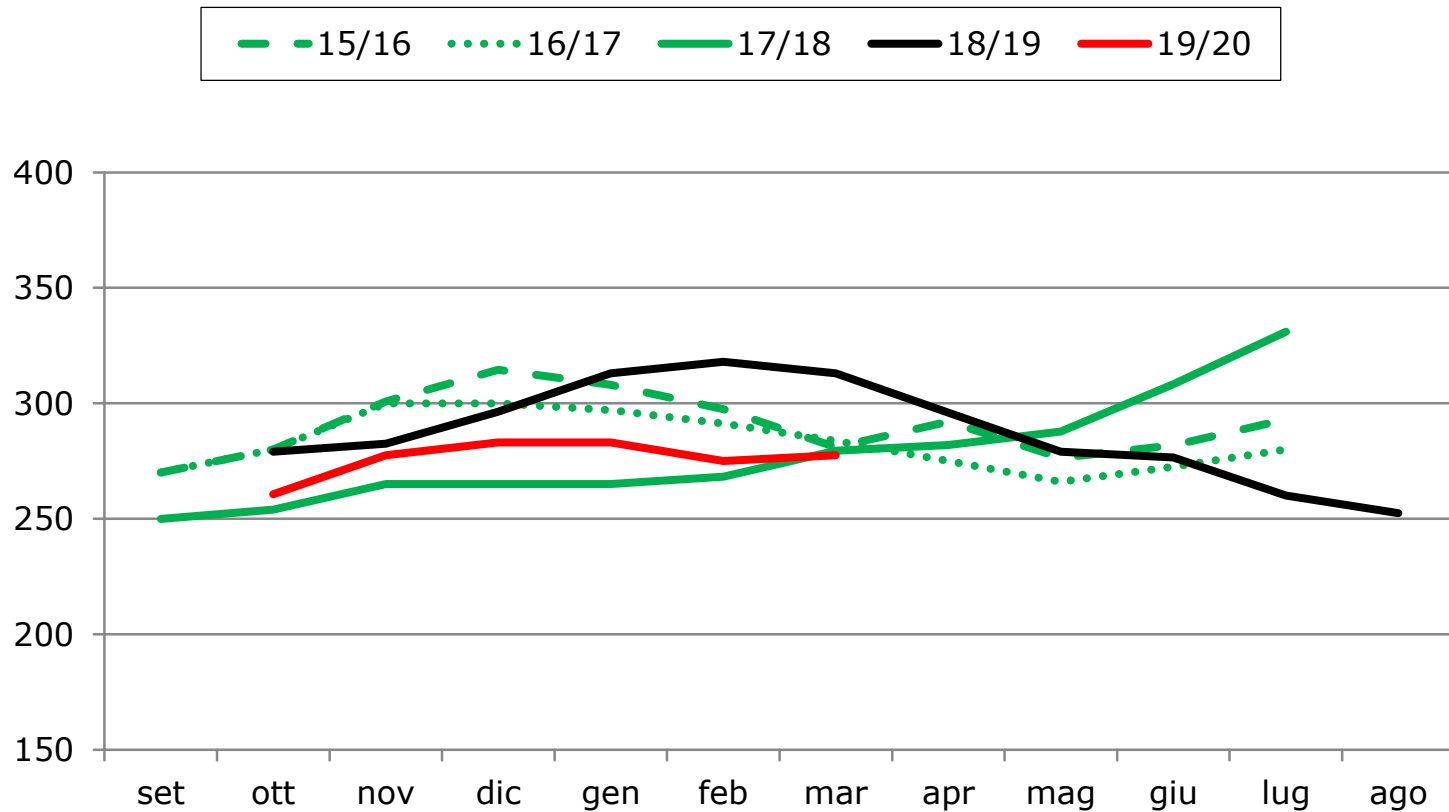

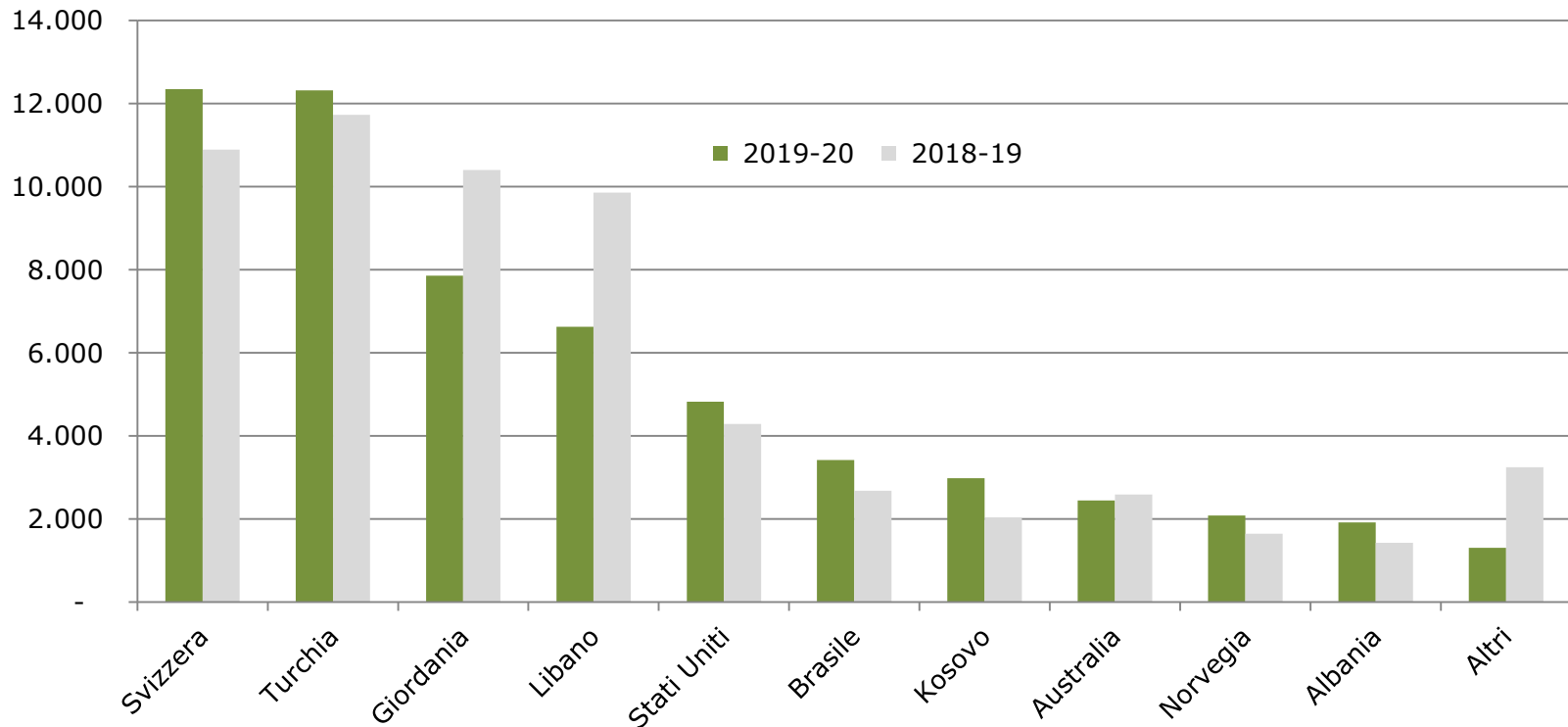

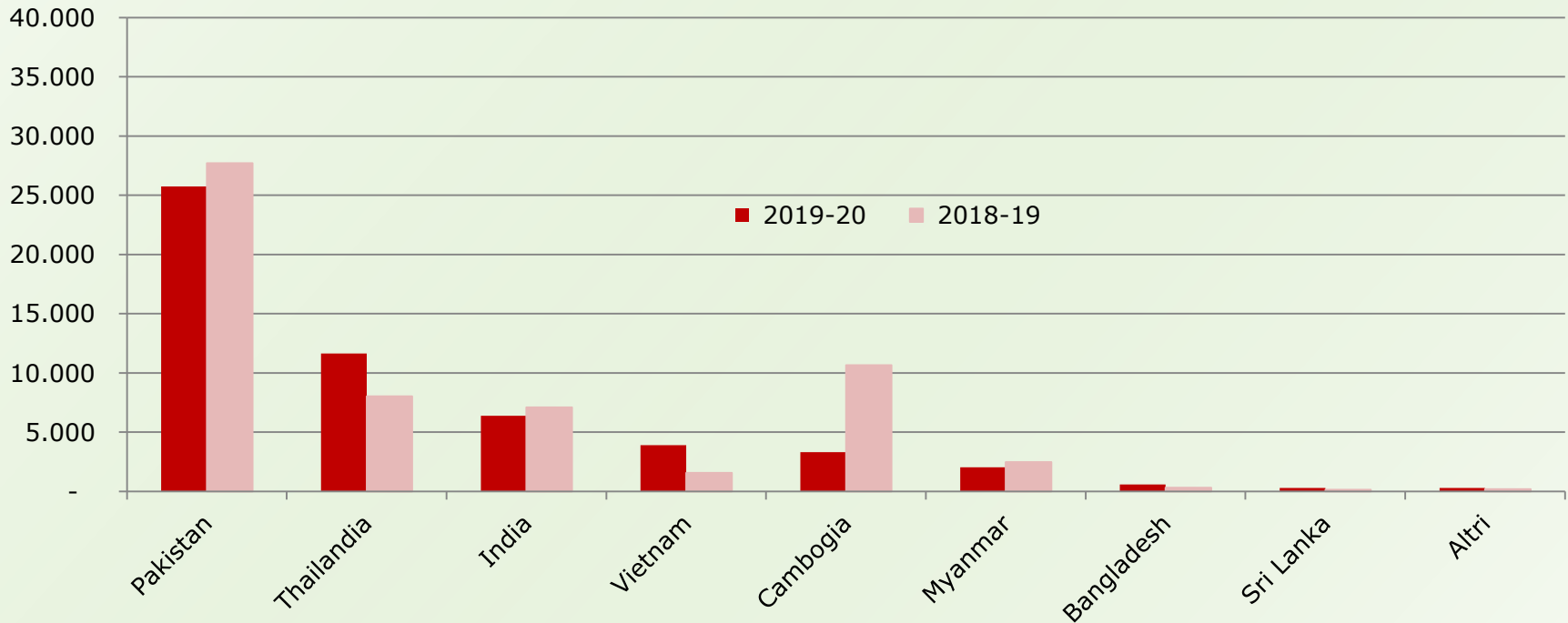

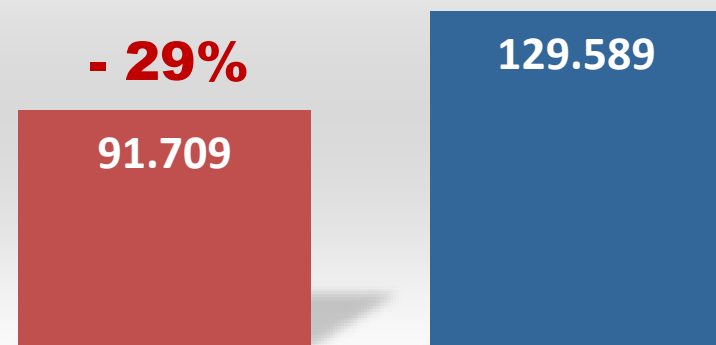
### Import Ue di riso semilavorato e lavorato da Cambogia e Myanmar (dati in tonnellate)

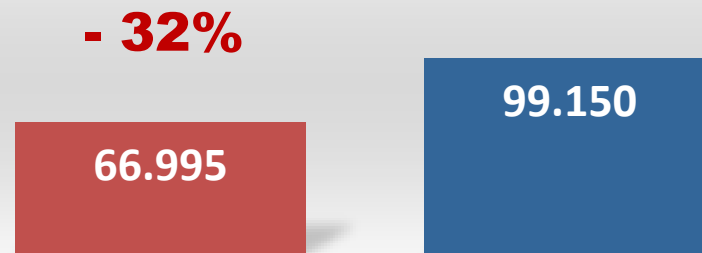
